Bids documents shall be sealed in an envelope addressing to the Darma Rural Municipality Office, Salyan indicating name of the contract, contract identification number, bidder's name and address.
5. Sealed Bids document shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs of 2075- 7-19 at Darma Rural Municipality Office, Salyan.
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
7. Each Bidder shall submit only one bid, either individually or as a partner in a joint venture. The maximum number of joint venture partners is limited to three.
8. Bids documents must be valid for a period of 90 days after bid opening and must be accompanied by Bid Security of NRs. 2,85,000.00 which shall be valid for 30 days after the bid validity period. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited as given in the following information:
